## **Rules for Participation:**

- Contestants must be at least 18 years old.
- Each contestant will have 4 minutes to eat as many fresh jalapenos as possible.
- Contestants will not be allowed any other foods or beverage during the contest.
- Contestants will be disqualified if they are unable to keep peppers down.
- Contestants cannot coat the inside of their mouth with any kind of protective coating. Anyone caught doing so will be disqualified.
- Stems are counted at the end of the 4 minutes to determine the amount of jalapenos eaten.
- Contestants will be allowed to finish any pepper remaining in their mouth when time is called.
- Peppers must be eaten down to within 1/8 inch of the cap to be counted.
- The winner will be determined by the number of stems on the contestant's plate after time has been called.
- Should there be a tie, those that tied will be given a serving of 10 peppers. Whoever finishes these the fastest will be the Jalapeno Eating Champion.
